Call to Order: Pastor Tony Orlando presiding

After a period of praise and worship, the annual meeting was called to order at approximately 11:31 a.m.

Minutes from January 26, 2020:

The minutes from the January 26, 2020 Shareholder's meeting were made available publicly on the home page of the Lifepoint Church web site. No questions or corrections were presented.

Looking Back at 2020:

Pastor Tony reviewed the operations of Lifepoint Church in 2020. Due to the inability to meet in person for 21 weeks of the year, traditional attendance metrics were not available. He noted that the shift in delivery methods during the year have given rise to visits on Facebook, Facebook live, online meetings and other non-traditional forms of engagement. Pastor Tony went on to compare the 'budget' and 'actual' giving levels for the last three years. In 2020, Lifepoint operated under its largest adopted budget to date of \$210,000. Despite the considerable challenges to church operations, giving reached a new high of \$273,529, exceeding budgeted expectations by \$63,529. He also reported on a current balance in our Expansion Fund of \$57,660.78. Pastor Tony expressed his appreciation for the congregation's continued engagement and faithful giving.

Looking Ahead to 2021:

Pastor Tony spoke of the major program allocations for the 2021 budget. Those details are in the copies of the slides included with these minutes. Lifepoint Church maintains a commitment to giving 10% of its revenue (a tithe) to several local and world-wide mission programs. The detail of that distribution is attached.

Board of Director Update:

Pastor Tony acknowledged outgoing Board members Corina Culver and Portia Keena for their service on the Board. Their seats were not filled immediately, however a quorum still remains with the remaining board members. An announcement will be made at a later time concerning board appointments.

Vision of Lifepoint Church:

Pastor Tony reviewed Lifepoint's core values along with the principals that will help guide decision-making in the coming year;

1. Does it strengthen the body?
- 2..Does it serve the City?

Word for 2021:

Pastor Tony identified the word in which he feels led for the coming year; the word "Fortify." He reviewed definitions of the word and how it might apply to our church being prepared for events in the coming year.

Adjournment:

The annual shareholder's meeting was concluded with prayer at approximately 12:16 p.m.
